"Heterogeneous conformism and wealth distribution : The Case of Elastic Labor Supply". Should be revised and resubmitted to *Economic Modelling*

This paper investigates, in a neoclassical growth model, the impact of consumption externalities on the distribution of wealth. The paper jointly accounts for heterogeneity in the degree of consumption externalities, heterogeneity in the initial wealth endowments and endogeneity of labor supply. First, we show that catching up occurs when the extra income acquired by the initially poorer household, by working more than the initially wealthier household, offsets the initial wealth difference. Second, reduction of wealth inequality is consistent and systematic only if an initially wealthier household works relatively less than the social average. When this latter condition is not met, reduction in wealth inequality occurs only if the initial wealth is highly unevenly distributed.

"Environmental tax reform and employment when revenues are recycled as subsidies to clean goods". Under review at *Environmental Modeling & Assessment*

This article studies the impact, on employment and environmental quality, of an environmental policy consisting of taxing polluting goods and subsidizing the consumption of non-polluting goods. We show that, when preferences for clean goods are higher than preferences for dirty goods, such a policy promotes employment. However, its effects on environmental quality remain ambiguous. Firstly, we observe an improvement in environmental quality through a reduction in the consumption of polluting goods. But as households' purchasing power increases as a result of the subsidy, their consumption of polluting goods tends to rise, calling into question the initial drop observed.

"On the labor supply effects of social benefits : the role of social status", Working paper

This article investigates whether the negative impact of social benefits on work motivation can be counterbalanced by households' pursuit of higher social status. Analyzing data from

the European Social Survey covering the period 2002 to 2010, our results consistently show that working hours are relatively lower among households whose main source of income is social benefits. However, these effects on labor supply are attenuated among individuals seeking higher social status.
